## Scope and Services

Safety is the number one concern for students, staff, and visitors here at Mingo Extended Learning Center. We realize that a safe environment effectively contributes to our learning ability.

## **GOALS AND OBJECTIVES**

Our goals at MELC is to implement safety in our technical programs as well as work on improvement of health and safety of the facility. Safety of the facility includes addressing sidewalks, lighting inside and outside the facility, and overall maintenance of the facility. Teachers address safety by performing fire drills, continuing education, emergency plans, and safety plans. Our Crisis Response is available with names and contact information of individuals and instructions in the event of a crisis. Inspections of the facility is done regularly and based on protocol and all staff is involved in the process.

### Resources

All staff are included in overseeing the Health and Safety Plan. They should report any changes that they think need made to the administrator for opportunities of improvement. As a technical facility we have Practical Nursing instructors who are certified in Basic Life Support and have had experience in the medical field that are trained to assist in the event of a sickness, accident, incident, or an emergency situation. We also have a list of contact information of local authorities and other individuals to contact in the event of a crisis. Maintenance is also available upon request for any technological or facility needs.

### Hostage

- 1. Announcement B using code
- Contact authorities (police, sheriff/county deputies)
   Mr. Hoffman will contact authorities and superintendent of Mingo County Schools
   Hazel Murphy will meet authorities at the front entrance of the school.
- If emergencies occur, please do the following:
   Lock classroom doors, pull shade over windows, stay quiet and out of sight until you are notified by authorities to evacuate.
  - A. If crisis occurs in one of the T & I rooms evacuate your students to Burch PK-8 Auditorium
  - B. If crisis occurs in the new addition of the main building, evacuate students to the front of the parking lot.
- 4. When authorities arrive, let them assume control.

If safe, announce ALL CLEAR
If unsafe announce ALL CLEAR NOW

  - A. Take students to Burch PK-8
  - B. Students will go to the Burch PK-8 Auditorium

## Possession of Firearm/Deadly Weapon

- 1. Follow hostage situation procedure if needed

## **Fire Explosion**

- 1. Follow fire drill procedure.
- 2. Report what type of fire to Mr. Hoffman, Mrs. Murphy and Mrs. Hatfield.

## **Medical Emergency**

- 1. Call 911—School nurses will administer first aid (ambulance will be called by the direction of the administrator of the school or the school nurse.
- 2. Kevin Salmons will meet ambulance at front entrance and direct them to the emergency.
- 3. Parents/Spouse will be notified by secretary or administrator.

## **Natural Disaster**
